# **Section 4 - First Aid Measures**

#### Inhalation

If inhaled, remove affected person from contaminated area and keep at rest in a position comfortable for breathing. Seek medical attention. Apply artificial respiration if NOT breathing and immediately seek medical attention.

#### Ingestion

Do NOT induce vomiting. Wash/rinse out mouth thoroughly with water. Seek immediate medical attention.

#### Skin

If on skin (or hair) remove/take off all contaminated clothing immediately. Wash/rinse skin gently and thoroughly with water/shower and non-abrasive soap for 15 minutes after handling. Ensure contaminated clothing is washed before re-use or discard. Seek immediate medical attention.

#### Eye

If in eyes, hold eyelids apart and flush the eyes continuously with running water. Remove contact lenses, if present and easy to do. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Seek immediate medical attention.

#### Precautions in connection with Fire

Fire fighters should wear full protective clothing and self-contained breathing apparatus (SCBA) operated in positive pressure mode. Fight fire from safe location.

#### **Section 6 - Accidental Release Measures**

#### **Emergency Procedures**

Evacuate all unprotected personnel. Do not allow contact with skin and eyes. Do not breathe mist/vapour. It is essential to wear self-contained breathing apparatus (S.C.B.A) and full personal protective equipment and clothing to prevent exposure. Avoid exposure to spillage by collecting the material using vacuum and transfer into suitable labelled containers for subsequent recycling or disposal. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Dispose of waste according to applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

Spillages will be very slippery. Wash site of spillage thoroughly with water.

# Section 7 - Handling and Storage

#### **Precautions for Safe Handling**

Corrosive liquid. Attacks skin and eyes. Causes burns. Avoid breathing in vapours, mist or fumes. Wear suitable protective clothing, gloves and eye/face protection when mixing and using. Use in designated areas with adequate ventilation. Keep containers tightly closed. Ensure a high level of personal hygiene is maintained when using this product, that is, always wash hands after handling, and before eating, drinking, smoking or using the toilet facilities.

#### Conditions for safe storage, including any incompatibilities

Corrosive liquid. Store in a cool dry well-ventilated area. Store away from oxidising agents and bases/acids. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks. Provide a catch-tank in a bunded area. Store in original packages as approved by manufacturer. Ensure that storage conditions comply with applicable local and national regulations.

For information on the design of the storeroom, reference should be made to Australian Standard AS 3780 The storage and handling of corrosive substances.

# **Section 8 - Exposure Controls and Personal Protection**

#### **Occupational exposure limit values**

No exposure standards have been established for this material. However, the available exposure limits for ingredients are listed below:

Potassium hydroxide 2 mg/m<sup>3</sup> (Peak) TWA (Time Weighted Average): The average airborne concentration of a particular substance when calculated over a normal eight-hour working day, for a five-day week.

STEL (Short Term Exposure Limit): The average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

Peak Limitation: A ceiling concentration which should not be exceeded over a measurement period which should be as short as possible but not exceeding 15 minutes.

#### **Biological Monitoring**

No biological limits allocated.

#### **Engineering Controls**

This substance is hazardous and should be used with a local exhaust ventilation system, drawing vapours away from workers' breathing zone. If the engineering controls are not sufficient to maintain concentrations of vapours/mists below the exposure standards, suitable respiratory protection must be worn.

#### **Respiratory Protection**

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable vapor/mist filter should be used. Refer to relevant regulations for further information concerning respiratory protective requirements. Reference should be made to Australian Standards AS/NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.

#### **Eye and Face Protection**

Safety glasses with full face shield should be used. Eye protection devices should conform to relevant regulations. Eye protection should conform with Australian/New Zealand Standard AS/NZS 1337 - Eye Protectors for Industrial Applications.

#### **Hand Protection**

Wear gloves of impervious material. Final choice of appropriate gloves will vary according to individual circumstances. i.e. methods of handling or according to risk assessments undertaken. Occupational protective gloves should conform to relevant regulations. Reference should be made to AS/NZS 2161.1: Occupational protective gloves - Selection, use and maintenance.

#### **Body Protection**

Suitable protective workwear, e.g. cotton overalls buttoned at neck and wrist is recommended. Chemical resistant apron is recommended where large quantities are handled.
